Stallions are available for preview prior to the opening date.

All stallions will have an opening bid of \$250 and we request bidding in \$25 increments.

Bidding will begin at 8:00 pm, Wed. Jan. 25, 2012; auction ends at 11:59 pm, Feb. 29, 2012.

Breeding to be used in 2012 season.

If you own an UN-registered (grade) mare, please check with Stallion owner prior to bidding. Some only accept registered mares.

Stallions who do not receive bids when the auction ends will be put back up for auction for one week for a "Second Chance" bidding at a reduced opening bid.

NOTE: The Stallion Service Auction is for the stallion's **service fee only**. All other fees, mare care, shipping, A.I., etc., are the responsibility of the mare owner. Winning Bidder to abide by stallion's breeding contract.

And the fine print... All bidders must register with MidAtlanticSpeedhorse.com.

- Bidding will be conducted on individual Stallion's page(s) on MidAtlanticSpeedhorse.com.
- Mailed bids will be accepted if postmarked no later than February 22, 2012. Checks must be enclosed with bid. Checks will be returned immediately if bid is not accepted.
- Maximum bids may be placed via email to Roc_Mix@comcast.net. Must be time / date stamped by Feb. 28, 11:59 pm (one day prior to auction end).
- Winning bidder to pay (or arrange to pay) in full within 24 hours of winning the auction. Checks, cash or credit cards via PayPal. Paypal payments will be charged 3% service fee (strictly to cover expenses).
